Single-Use License for Non-exclusive Stock Art

License

The image(s) overseen by this single-usage license is for product, which may include: print, pdf, web, or digital, along with their associated advertising. It may be used in single commercial product. You may also freely use it in any number of personal (non-commercial) projects as you wish.
